To increase public and first responder safety, and facilitate a more rapid response to crimes in progress, the Mesquite Police Department (MPD) seeks funds to assist with the purchase of ProQA Emergency Dispatch software and the interface module associated with the department's computer aided Spillman dispatch program.

The purchase of ProQA Emergency Dispatch software package for medical, fire and law enforcement will put an automated system on the dispatcher's screen that will allow the dispatcher to collect vital information from callers, through a series of yes and no diagrams that will direct them to the next steps in the questioning process depending on the answers the caller is giving them.

MPD Dispatchers currently use manual systems in the 911 call center. Dispatchers look away from the monitor and flip through a stack of cards or look into a binder to access questioning diagrams based on the protocol. The dispatcher must then decide to code the call at an ADAM, BAKER, CHARLIE or DELTA level.

ProQA software uses logical rules based on industry expert training to collect vital information from callers and suggests an appropriate dispatch level. Utilizing software data the dispatcher can then instruct the caller with industry approved protocols until dispatched units arrive on the scene.

ProQA software provides dispatchers with hundreds of protocols with key questions to assist the dispatcher in quickly determining the appropriate level of response. The software prompts the dispatcher in pre-arrival instructions and post-dispatch instructions. ProQA also provides early dispatch support when the caller indicates someone at the scene is not safe and in danger. Responses given by callers to the ProQA series of questions will direct dispatchers to the DISPATCH LIFE SUPPORT Link that will help maintain life and safety at the scene until emergency responders arrive.

The purchase of the software will give MPD dispatchers access to hundreds of protocols, including active assailant, active shooter and on screen step by step instructions for CPR, CHOKING, CHILDBIRTH. ProQA is a nationally recognized emergency dispatch program that is currently used in other law enforcement and fire protection agencies in Clark County.

In the event of a lawsuit, arising out of the protocol methodology, the Priority Dispatch Corporation will provide expert witness testimony in regards to the protocol standards which are set by a College of Fellows. The College of Fellows consists of forty industry experts who frequently review and test dispatch protocols for effectiveness and best practice.

The Police and Fire Departments made a request during the 2013-2014 hearings. The request was pulled due to a 2.4 million dollar budget shortfall.

The City of Mesquite will be responsible for the annual maintenance fees associated with maintaining the ProQA software and the Spillman Interface.

 b) Please describe how the matching funds, if any will be obtained: The MPD wrote a JAG grant request for the total program cost in June of 2013. A portion of the program has been funded through JAG grant funds.



Back up has to come from the Pershing County Sheriff Office and they don't always have a deputy on duty or he could be up to eighty (80) miles away. In some cases with no deputy on duty, dispatch has had to call another city officer out.

There is also a local attorney who reviews the PC sheets and picks and chooses which cases to defend, he is currently seeking litigation against the City and Lovelock Police Department.

The cameras would assist the City and Lovelock Police Department from possible litigation and or law suits.
