3. <u>Action Item:</u> Consideration and Approval of Loss Control Excellence Program Award for Boulder City Hospital

4. <u>Action Item:</u> Consideration and Approval of E-Discovery Resource Program including regional training workshops and toolkit resources for Risk Management Resource Library

Ann Wiswell introduced Peter Gronvall of the consulting firm Adams Grayson. Ann had attended a presentation given by Mr. Gronvall in Washington D.C. at a meeting of the Risk Management Advisory Committee for United Educators in November of 2009. Adams Grayson helps organizations meet the information management, preservation, and production obligations arising under federal and state procedural rules governing electronically stored information, by providing training, consulting and case management services.

Upon returning from the United Educators meeting, Ann had discussed the need for such information and training among the POOL members with claims manager, Donna Squires. Donna had agreed with Ann that this was a growing area of concern, as the legal costs associated with managing the "e-discovery" process was contributing to increased POOL claim costs.

Mr. Gronvall gave a presentation on the issues surrounding electronic discovery rules, presented a document tool kit including checklists and sample letters of preservation for the Committee to review and consider.

Upon motion and second, the Committee approved funding for five regional workshops on electronic discovery, the first to be delivered to the POOL legal panel counsel Litigation Strategy Committee meeting in February 2010. Funding had previously been set aside for four regional training workshops on Emergency Planning however these workshops were not delivered due to changes in scheduling conflicts between the trainer and members. The Committee reallocated the funds from Emergency Planning to Electronic Discovery training.
